- (c) To establish an institute of Bio Informatic Technology.
- (d) To establish and run a super speciality hospital.
- (e) To establish and run an oldage home.
- (f) To establish and run an orphanage.
3. An amount of Rs. 10000/- Rupees Ten thousand has been collected as the working capital of the trust at present and there is no landed properties etc owned by the trust.
4. There shall be a governing body composed of
- (a) Any person who have contributed to this trust a sum not less than Rs. 5,00,000/- Rupees Five lakhs only) and therein successes.
- (b) Representatives elected by persons who have contributed to this trust Rs. 10,00,00/- (Rupees one lakh only) and more but less than Rs. 5,00,000/- (Rupees five lakh only) provided that the members so elected shall be one fifth of total members of such subscribers.
5. The Governing body shall hold office for a term of five years provided that the existing governing body shall continue in the office until their successes assume office.
6. The governing body shall have power at any time and from time to time to supply any vacancies in the governing body arising from death, resignation or other causes.

7. POWER OF THE GOVERNING BODY.

(a) To manage and control the trust properties, the schools and other institutions belonging to the trust under their management.

(b) To frame such rules and regulations as are necessary.

(c) To ratify or reject all actions taken by the chairman and Secretary.

8. The Governing Body is authorised to borrow any amount not exceeding Rs. 10,00,000/- (Rupees hundred lakhs only) by security of the lands buildings and other assets of the trust or otherwise for any of the objects of the trust.

9. The Governing body of the trust shall have power to invest any surplus funds in any manner they deem fit in the interest of the trust.

10. The quorum of the governing body shall be five.

11. Powers and duties of the Chairman.

(a) The Chairman shall be the manager of the schools and Institutions belonging to the trust.

(b) The chairman shall be presided over the meetings of the Governing body. If the Chairman is absent members present in the meeting shall elect one among the members present at the meeting to preside. Where there is a difference of opinion in any meetings of the governing body, the opinion of the majority shall be deemed to be the decision of the Governing Body provided where the members are equally divided, the Chairman of the meeting shall have a casting vote.

(c) The appoint and remove all the staff of the institutions provides these orders have to be ratified by the Governing Body.

(d) To endorse bills cheques and sign other documents on behalf of the TRUST on Governing Body or any of the institutions of the TRUST.

(e) To operate all accounts opened with any bank in the name of TRUST or institutions under the TRUST and for that purpose to sign, endorse bills, cheques and other documents and other papers on behalf of the Governing Body or any other institutions under the TRUST.

(f) The Chairman shall be the powers to withdraw an amount not exceeding Rs. 3,00,000/- (Three lakhs only) from the bank or from Govt. Treasury or from Post Office at a time.

12. All documents shall be registered with the name of the Chairman.

13. The Chairman shall have the power to sign the sales deeds provided that the sales

14. Powers and duties of the Secretary.

(a) To appoint and remove all the staff of the schools and institutions if necessary after consulting with the Chairman provided that these orders have to be ratified by the Governing Body.

(b) The Secretary shall have the powers to withdraw a sum not exceeding Rs. 2,00,000/- (Rupees two lakhs only) from the banks or from Government treasury or post office at a time.

15. The financial year of the trust commence from 1st January and ended 31st December. It shall be the duty of the Chairman to remedy or rectify any defects on irregularity pointed out by the auditor.




16. The Secretary is responsible to convene the Governing Body once in three months and annual Governing Body meeting of the members.


17. It is the duty of the Secretary to submit annual report and Budget in the Governing Body and in the General Body meeting of the members.


18. One winding up of the said Trust the assets and liabilities will be transferred to the public charitable institutions having similar objects or to the Government.




20. The powers to make any additions and amendments in this bye-laws of the Trust as and when necessary shall rest with the Governing body of the Trust.




